

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Eagle Sky of the Ozarks (hereinafter "Eagle Sky") and The Bridge Community Church have put in place preventative measures to reduce the spread of COVID-19; however, Eagle Sky and The Bridge Community Church cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, participation in summer camp programs could increase your risk of contracting COVID-19.

BEFORE YOU OR YOU CHILD ARRIVE TO EAGLE SKY CAMP: Campers with known exposure to someone diagnosed with COVID-19 or those who have been in contact with anyone with illness of any kind in the past two weeks must stay home.

___ INITIALS By signing this agreement, I **acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I or my child(ren) may be exposed to or infected by COVID-19 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death.** I understand that there is a risk of becoming exposed to or infected by COVID-19 at Eagle Sky.

___ INITIALS I **voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself or my child(ren) (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation at Eagle Sky.** On my behalf, I hereby release, covenant not to sue, discharge, and hold The Bridge Community Church, Eagle Sky, its employees, agents, and representatives of each, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence The Bridge Community Church, Eagle Sky, its employees, agents, and representatives of each, whether a COVID-19 infection occurs before, during, or after participation at Eagle Sky Camp

___ INITIALS **By signing this document, I agree that if I am exposed or infected by COVID-19 during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.**

___ INITIALS **I agree that to the best of their ability my child will follow all camp safety guidelines laid out by Eagle Sky and will attempt to practice safe social distancing and clean hygiene at all times during their participation at Eagle Sky. Failure to comply with provided safety guidelines will result in your child's expulsion from camp.**
